Annual General Meeting

- a) Request the Company to include items on the agenda of the AGM, provided that each item is accompanied by a justification or a draft resolution to be considered at the AGM; and
- b) Table draft resolutions for items to be included in the agenda of the AGM.

The request to include such items or draft resolutions on the agenda of the AGM should be submitted to the Company in hard copy form or in electronic form to companysecretary@ihiplc.com at least 46 days before 9 June 2022, that is, by 25 April 2022 and shall be authenticated by the person or persons making it.

The Company will not entertain any requests by shareholders received after 25 April 2022.
